Dear Ms. Ingraham Willaman,

This is in response to your July 21, 2008 study plan requesting an amendment to Merrill Tawse's Federal Fish and Wildlife Permit No. TE1576792-0 to conduct a 2008 summer mist-net survey and radio-telemetry study for the Indiana bat (*Myotis sodalis*) at the 8.5-acre Lockheed Martin Site in Akron, Summit County, Ohio.

Please note the following new requirements for the 2008 field season:

- Due to concerns over White Nose Syndrome, we are now requiring that the Disinfection Protocol for Bat Field Studies be followed for all bat survey work in conducted in Ohio. The protocol is attached.

- We request that all Indiana bats be banded utilizing the NEW Ohio Department of Natural Resources, Division of Wildlife (DOW) bands. Please contact Suzie Prange (DOW) for questions and to request bands (740) 589-9924.

The Service has reviewed your proposal for the Indiana bat survey. This notification serves as written concurrence that Merrill Tawse is authorized to proceed with the Indiana bat survey as described in your request. Upon completion of the survey, we request that you submit a copy of the survey results to this office for review. Please include the latitude and longitude coordinates for the survey site in the report. If any Indiana bats are found during the survey, please notify this office within 48 hours.

Please carry a copy of this site specific authorization and your Federal permit while conducting the survey. If you have questions, or if we may be of further assistance in this matter, please contact me.
