Voluntary Cleanup Continues

Lockheed Martin's voluntary cleanup of Bloody Brook is continuing through the summer of 2015. Since mid-April, activities related to the remedial construction have been underway in the upstream portion of the site near the New York State Thruway down to Brookview Lane.

Summer 2015 Progress

Throughout June and July 2015, Lockheed Martin's remedial construction contractor AECOM continued to make progress restoring the 2014 construction area (wooded area) as well as excavating the soil and sediment along the brook near the Midwood Drive access area down to Brookview Lane. The cleanup of the former gabion (rock-filled wire basket) lined section of the brook began and it is being restored with more natural, gently sloping banks and with one section of retaining wall (due to slope steepness). Approximately 246 truckloads (5,625 tons) of soil and sediment have been removed so far in 2015, and 931 truckloads (19,288 tons) to date for the project. Backhoes, loaders and excavators are being used to dig up the soil. The dump trucks enter the site off Brookview Lane, near Sunflower Drive, to take soil off-site to licensed landfills

and to bring clean backfill onto the site for restoration. An additional access road has also been constructed off Brookview Lane near the intersection with Midwood Drive. This access will be used once the wooded area is restored and the access road near Sunflower Drive is removed and the area is restored. As in 2014, a bypass pump has been set up to divert the flow of the West Branch of Bloody Brook from the work area.

Upcoming Activities

Excavation of side banks, soils and the dry brook sediment will continue from Brookview Lane downstream throughout the summer. In addition, the culverts which carry the brook under the roads in the neighborhood also will be replaced. The culverts, which are beginning to fail, would have been replaced by Onondaga County in the next few years. So as not to disturb and inconvenience the neighborhood twice, Lockheed Martin is helping the County by replacing them during remediation process. Beginning in early August, the Brookview Lane culverts will be replaced and a portion of Brookview Lane will be closed except to local traffic. The culverts under Sunflower Drive and Floradale Road will be replaced later in the summer as the cleanup continues downstream.

Lockheed Martin will continue to restore areas upstream by replanting land areas with seed, shrubs and trees, and enhancing the brook side banks to improve flow and storm water movement. Weather permitting, AECOM should have most of their construction vehicles and equipment out of the most upstream portion of the site and have the wooded area restored before the end of the summer.
